**PLEA AGREEMENT**

The following is the plea agreement between the parties:

**CC 2018-160**

Upon a plea of guilty to Count 1 Felony Murder as charged in the indictment, the defendant shall be sentenced as follows:

- Sentenced to **240 months split 60 months** in the Custody of the Department of Corrections;
- Upon release from the Department of Corrections, the defendant shall be placed on **60 months of State supervised probation**;
- As a condition of probation, the defendant shall not possess any firearms;
- Defendant to get credit certified by the clerk for the amount of time served in jail;
- Defendant shall pay Court Cost;
- \$1,000 Fine
- \$50 Alabama Crime Victim's Assessment Fee;
- Restitution to be determined;

Upon a plea of guilty to Count 3 Discharging A Firearm Into an Occupied Vehicle as charged in the indictment, the defendant shall be sentenced as follows:

- Sentence to **180 months split 36 months** in the Custody of the Department of Corrections;
- Upon release from the Department of Corrections, the defendant shall be placed on **36 months of State supervised probation**;
- As a condition of probation, the defendant shall not possess any firearms;
- Defendant to get credit certified by the clerk for the amount of time served in jail;

**CC 2023-66**

Upon a plea of guilty to Count 2 Assault 2<sup>nd</sup> Degree of the indictment, the defendant shall be sentenced as follows:

- Sentenced to **120 months split to serve 24 months** in the Custody of the Department of Corrections;
- Upon release from the Department of Corrections, the Defendant is to be placed on **36 months** of State Supervised Probation;
- Defendant to get credit certified by the clerk for the amount of time served in jail;
- Court Costs;
- \$50.00 Alabama Crime Victim's Assessment Fee;

As part of the plea agreement, all cases are to run concurrently. The following charges will be dismissed:

- Counts 2 and 4 in CC 2018-160
- CC 2023-26
- Count 1 Promoting Prison Contraband 1<sup>st</sup> in CC 2023-66
- CC 2019-425
