COUNT 1

The grand jury of said county charge that, before the finding of this indictment, Martavious Billingsley, whose true name is otherwise unknown to this grand jury, did on or about May 30, 2018, committed or attempted to commit any other felony clearly dangerous to human life and, in the course of and in furtherance of the crime that he is committing or attempting to commit, or in immediate flight therefrom, he or another participant caused the death of any person, to wit: Kenbranesha Rayford, in violation of §13A-6-2 Alabama Code (1975) against the peace and dignity of the State of Alabama. This offense occurred at or near Marie Foster Street, Selma, Dallas County, Alabama.

COUNT 2

The Grand Jury of said county further charge that, before the finding of this indictment, Martavious Billingsley, whose true name is otherwise unknown to this grand jury, did on or about May 30, 2018, aid and abet in the shooting or discharging a dangerous projectile into any occupied automobile, to wit: a brown Buick in violation of §13A-11-61 Alabama Code (1975) against the peace and dignity of the State of Alabama. This offense occurred at or near Marie Foster Street, Selma, Dallas County, Alabama.

COUNT 3

The Grand Jury of said county further charge that, before the finding of this indictment, Martavious Billingsley, whose true name is otherwise unknown to this grand jury, did on or about May 30, 2018 aid and abet with intent to cause physical injury to another person, to wit: Calvin Craig, caused physical injury to any person, to wit: Calvin Craig, by means of a deadly weapon or a dangerous instrument, to wit: firearm, in violation of §13A-6-21 Alabama Code (1975) against the peace and dignity of the State of Alabama. This offense occurred at or near Marie Foster Street, Selma, Dallas County, Alabama.
